## Summer Tax 2014

Beginning July 1, 2014 summer taxes are due. Please make checks payable to Green Charter Township. Payments may be mailed to: PO Box 23 Paris 49338, dropped in the after-hours drop box located in front of the Township Hall, or brought to the Treasurer's office during the hours listed on the back of this letter. If you require a receipt, please enclose a self-addressed stamped envelope.

**Escrow Accounts:** Upon request of a mortgage company, a copy of the tax bill will be forwarded. The original tax notice is sent to the property owner.

**Summer tax bills must be paid by Monday, September 15 to avoid incurring a monthly 1% interest added to unpaid balances.**

Deferral forms are available to select properties. To receive the deferral, the form must be complete each year and returned to the Treasurer by September 15.
