PUBLIC COMMENT: Larry V.- Can you give us an amount on what has been paid for legal fees for fighting Gotion? We lost money from them suing us and that is our tax dollars. Paul Q.-The minutes aren't showing up correctly on the website (known glitch, we are working on). Brenda H.-28 year resident, wants to talk about one of our own tonight. He's making a trip to Washington DC in October. His name is James Johnson, Jim served with the Army National Guard in 1974 during the end of Vietnam. Jim continued serving for 26 years and ended in 2001. We are sponsoring him for the trip. Jim served and is still serving our community. He was on the road commission and was the supervisor at the Morley Garage. Thank you, Jim to your commitment to our community and country. Karen L.- After hearing concerns about tax money being used to fight Gotion. Our tax money is also being used to fund Gotion so it's coming out of your pocket. Rhonda L.- US House passed a bi-partisan legislation that prohibits the use of batteries by Gotion. I know there is a lot of talk about Gotion, but even the US Government is taking notice.

CORRESPONDENCE:

ADDITIONS TO AGENDA: Time to think about snow plow bids again. The next election commission meeting will need to be scheduled soon. Dan Hoeh talked about the Big Dam Bike Ride this Saturday. Many people from all over the country will be participating. Henderson stated that the last day to pay taxes on time is Monday, September 16th. PUBLIC COMMENT: Ginny V.- My goal is to try and figure out what is going on with Gotion and where our tax money is going. Is the board trying to shut Gotion down? Can we get an answer in a few weeks, months or years? Supervisor stated that we do not have an answer to that right now. Steve O.- I asked last month and would still like the board to consider getting rid of the admin fee to pay taxes. It's a matter of principle. Also would like to help offset the cost by working with people to try and raise funds that would be lost. Maybe a chicken dinner or something like that? Larry V.-We heard from Karen that the state is giving Gotion \$178 million. I'm assuming that is a tax credit. The state is not paying them to set up shop?
