**PUBLIC COMMENT-** Residents discussed road conditions, attorney fees, Gotion.

**CORRESPONDENCE:**

**ADDITIONS TO AGENDA:** Resolution to Amend the Sewer Budget of Fiscal Year 2024-2025, 2025-06. This resolution would add \$15,500 to 819 Engineering from 818 Contracted Services (\$12,500) and 817 WWTP O&M GN Twp (\$3,000). A motion was made by Walsh to approve Resolution 2025-06, supported by Meads. Motion was passed unanimously on a roll call vote.

BEAD Grant; Supervisor Kruse gave an update on requests from various Internet companies asking for support from the township to expand fiber internet and make it more available to residents.

There is no commitment, obligation or contract needed from the township.

Pursue a full CFIUS of Gotion. Supervisor Kruse is asking for board approval to contact other municipalities seeking support in filing a full CFIUS review of Gotion. CFIUS is the Committee on Foreign Investment in the United States. A motion was made by Cushway to authorize the Supervisor to coordinate with legal council and other units of local government related to potential review of the Gotion project by the Committee on Foreign Investment in the United States.

Supported by Meads. Motion passed unanimously on a roll call vote.
