LIFT STATION SYSTEM MONTHLY ACTIVITY SUMMARY

The following is a list of activities that were performed during the third quarter lift station inspections:

- Noted current generator run time
- Inspected main control panel
- Ran both lift station pumps in hand to verify proper pump operation
- Checked inside and in the surrounding area of the wet well at the lift station for any garbage or debris
- · Performed visual inspection of the check valve pit
- · Cleaned the seal filters
- No grease or debris observed in the wet well therefore no degreaser was added
- Tested floats for proper operation
- Verified all lights are functional
- Performed inspection of the exhaust fan
- Inspected all ladders and the heater
- Tested amp draws on both pumps (data below)
- Checked generator and verified it is operational
- One service call on 7/18 for a failed transducer. Hooked up the backup floats while on site.
- Motor greasing will be performed on an annual basis





Photo of Inside Wet Well 9/11/24
